



St. Charles Celebrates Bicentennial Anniversary—

On October 13, 2009, St. Charles will officially celebrate the 200th anniversary of its 1809 incorporation as a village. But don't worry, you won't need to wait that long to get in on the festivities. A committee comprised of more than 25 volunteers has teamed up with city staff to plan Bicentennial events and activities giving residents, business owners and visitors an opportunity to celebrate the city's rich heritage and history all year long.

According to Karen Godfrey, tourism staff member and planning committee chair, the Bicentennial will kick off at the end of March and weave its way through some 200 happenings slated for our fair city throughout the coming year. For your easy reference, here's a quick look at the initial highlights:

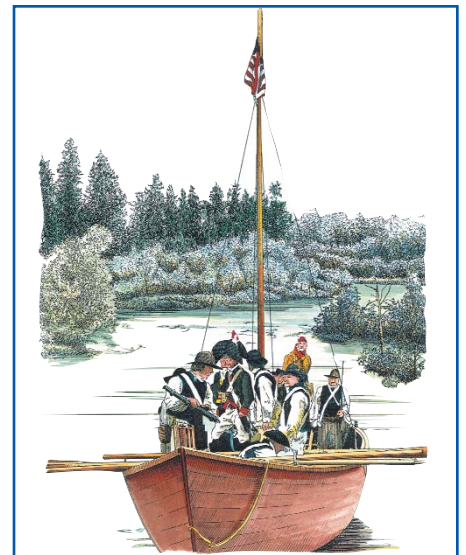
Event participants are invited to wear clothing symbolic of the passing of

time from 1809 until present day. The evening will include heavy hors d'oeuvres focusing on our French, Spanish and German heritage. Live entertainment will be provided by Crossover, a dynamic seven-piece band.

**Saturday, March 28 --
Three Flags Ceremony
Frontier Park
11 a.m.**

This unique flag-raising ceremony will mark the transition of the Louisiana Territory in 1804 from Spain to France to America. Featured in the line up will be The Lewis & Clark Fife and Drum Corps as well as a host of period reenactment characters.

"Stay tuned for more information as the second weekend in October will feature a cultural heritage festival based on a series of parties, parades and concerts in local St. Charles parks, with **Frontier Park slated for October 9, Blanchette Park on October 10 and Wapelhorst Park on October 11**," Godfrey said. "Plus, we're planning a number of events for children and adults, alike. This anniversary celebration will offer something for everyone in town." For longtime residents who were around in 1969, the overall anniversary theme might sound somewhat familiar. That's when St. Charles hosted another round of Bicentennial festivities. Those honored French Canadian Louis Blanchette's establishment in 1769 of the small settlement of Les Petites Cotes, or Village of the Little Hills, in what is now known as present-day St. Charles. By the time St. Charles was incorporated as a village in 1809, there were more than 400 residents.

General Utility Tax Refund Guidelines

(Information Hotline: 636-255-6145)

The Mayor and the City Council of the City of St. Charles have passed an Ordinance that will refund the City taxes you've paid to your Gas and Electric utility companies. The total refund available shall not exceed one hundred dollars (\$100.00).

For your information, the specific charges or fees that are refunded are those that were paid to the City of St. Charles. On your AmerenUE bill, the line item is titled, "St. Charles Municipal Charge." Your Laclede Gas bill refers to this as "St. Charles Tax." Keep in mind that the maximum allowable refund amount is \$100.00. If, for example, your St. Charles taxes paid to the Laclede Gas company totaled more than \$100.00, your electric bills will not be necessary.

TO QUALIFY:

- You are at least 62 years of age and live within the city limits of St. Charles.
- You are not yet 62 but your only income is total disability.

YOU WILL NEED TO PROVIDE:

- Original or legible photocopies of your gas and electric bills from April of last year through March of this year. **(If you wish to retain your original bills, please provide us with copies.)** At your request, both AmerenUE and Laclede Gas will send you an itemized list of the City taxes you paid during **April of 2008 through March of 2009**. These lists are acceptable in place of your actual electric and gas bills.
- Proof of age by a valid driver's license, Missouri non-driver's identification, passport or birth certificate.
- If you are not yet 62 but your only income is total disability you must provide a copy of certificate of total disability from the Social Security Administration.

TO APPLY:

Applications will be accepted April 1st through May 31st.

- **BY MAIL:** If you choose to mail your bills to City Hall, be sure to include a copy of your proof of age, original/legible photocopies of your gas and electric bills (or tax statements from AmerenUE and/or Laclede Gas). Please understand that due to the expected high volume, **we will not be able to return original documents.** Our address is Utility Tax Refund, Office of the Mayor, Room 400, 200 North Second Street, St. Charles, MO 63301.
- **IN PERSON:** Bring proof of age and original/legible photocopies of your gas and electric bills (or tax statements from AmerenUE and/or Laclede Gas) to the first floor Rotunda (or Lobby) of City Hall located at 200 North Second Street. Application forms will be available.
Applications will be accepted weekday mornings between the hours of 8:00 AM and Noon. Staff will be available to assist you.

The following information is required for persons applying for a refund of the utility taxes paid on electric and natural gas bills.

- Applicant shall be at least 62 years of age or older. Applicant must provide proof of age by a valid driver's license, Missouri non-driver's identification, passport or birth certificate.

OR

- Certified as totally disabled by the Social Security Administration. Applicant must provide a copy of certificate of total disability from the Social Security Administration.

AND

- Applicant must own or lease residential property located within the City of St. Charles and occupy the same as his/her customary place of residence.
- Applicant shall provide to the City original or legible photocopies of gas and electric bills **from April 1 of the prior year through March 31** of the current year.
- The total refund available shall not exceed one hundred dollars (\$100.00).

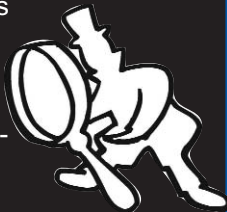

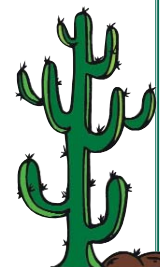

Trash and Recycling

The Solid Waste Committee continues to review the Allied contract, and will review once a week trash pick up and the recycling program in six months. Since introducing the 62 or 35 gallon recycling carts January 1, recycling volume for St. Charles city has nearly doubled! Thanks to all participants.

Requests for cart changes (size) or new requests for carts should be made by April 20. Allied will begin picking up the 18-gal. BINS the week of April 20.

Yard Waste – March 1

Customers who participate in the yard waste program, should put their **PAPER** bags out for pick up beginning March 1. **PLEASE NOTE: up to ten bags** will be picked up without additional charge. If you wish to put out yard waste and do not participate in the program, you may purchase tags at Dierbergs or IGA for \$3 each (one tag per bag). Tagged bags may be put out on Wednesdays any month of the year. Please note yard waste cannot, by law, be mixed with trash and must be placed in 32-gal. cans or bags.

Bulky Items

Bulky items include any type of solid waste that cannot be placed in a 32-gal. trash cart. Items over four-ft. in length must be broken down and bundled. Bulky items are picked up only during your last pick up day of each month. Construction and remodeling debris is not considered Bulky Waste. Please call Jeri for instructions.

Major Appliances/White Goods

These items cannot go into a landfill. Please call Jeri Eaton at 636-255-6142 for pick up; there will be an additional charge. Tires and batteries cannot be picked up.

If you need additional information regarding what can be recycled, please call Jeri Eaton at 636-255-6142 or refer to the calendars distributed citywide earlier this year. Single stream recycling allows us to put recycled material (except plastic bags and Styrofoam) in one receptacle.

Rec Center Update

St. Charles continues to move forward in planning our new Community Freedom Center in conjunction with Show Me Aquatics & Fitness. The 125,000-square-foot recreational center will be located on the former K-Mart site just off Veteran's Memorial Parkway. The Oversight Committee meets on a regular basis to discuss plans for this amazing, one-of-a-kind facility. Representing the City of St. Charles are: Mayor Patti York, and City Council representatives Michael Weller, Bob Kneemiller, Laurie Feldman and Mike Klinghammer. Representing Show Me Aquatics are: Patrick Banger (chairperson), Jim Cochran, Dr. Bess Maxwell, Bud Schaeffer and Sue Schaeffer. Show Me Aquatics has purchased and closed on the K-Mart facility property. The Oversight Committee is currently in the process of finalizing the interior layout and design. This state-of-the-art facility is scheduled to open in 2010.

FBI Academy

Congratulations to Lieutenant Donovan Kenton, who received special recognition during the January 6 City Council meeting for his completion of the prestigious FBI National Academy. During fourth quarter 2008, Donovan spent 10 weeks in a professional course of study located on campus in Quantico, Virginia. The program, offered for U.S. and international law enforcement leaders, serves to improve the administration of justice in police departments and agencies at home and abroad. Donovan participated in a wide range of leadership and specialized training opportunities. Focus areas of the academy, include: law, behavioral science, forensic science, leadership development, communication and health/fitness. Participation is by invitation only, through a nomination process. Participants are drawn from every state in the union, from U.S. Territories, and from over 150 foreign nations.

Economic Development

Nadine Boon, CEcD, Director, Economic Development, was recently elected to a third, three-year term for the Board of the Missouri Economic Development Finance Association (MEDFA). The group's mission includes education and advocacy concerning all economic development financing tools available in the State of Missouri. The Association also promotes the responsible and ethical use of all development financing incentive programs. Membership encompasses 23 statewide board members, including community economic development directors, public officials, real estate developers, attorneys and financial professionals. Nadine was first elected to MEDFA in 2002, and also served a second term beginning in 2005. She served as the conference chair when MEDFA's annual conference met at the St. Charles Convention Center in 2006.

Sewer Laterals

The Lateral Sewer Insurance Program provides St. Charles homeowners the benefit of an "insurance policy" on lateral sewers to their homes. This benefit applies to single-family homes, duplexes, condos or a residential development containing not more than six dwelling units. This insurance program covers excavation, repair or replacement of the sewer lateral, backfilling, and seeding and strawing of the disturbed portion of the yard. If claims are approved, the City will pay 80 percent of the cost of repairs to lateral sewers (up to \$5,000 per property), and the homeowner will pay 20 percent. During her career with the CVB, Little initially served in a variety of support staff functions for some ten years.

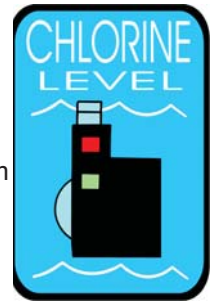

ENVIRONMENTAL CONCERNS

Swimming pool season is just around the corner which means chlorine and other pool chemicals. This is a reminder that discharge of chlorinated water to the storm sewer system is regulated. Discharge of chlorinated water from a pool or spa can harm fish or other aquatic life. Chlorinated water from a pool should only be discharged after the chlorine has dissipated. This generally requires a week to ten days after the last chlorine treatment. The discharged water should be spread on the lawn and allowed to runoff slowly. This helps further reduce the chlorine content and lessens any environmental concerns.



MOSQUITO SCHEDULE

It's that time of year once again.

While we long for warmer temperatures and the arrival of spring, the folks in Community Development are busy mapping out the 2009 mosquito spray schedule. As in year's past, spraying efforts will begin towards the end of May, dependent upon the weather. The general time-frame for spraying will occur between the hours of 7 and 10 PM. This year, the spray schedule for St. Charles neighborhoods will be as follows (please note this may be subject to change, as required):

- ✓ Collaborative design—
At each stage of the process city officials and community members were engaged to ensure the process and the product meets the community's goals and objectives.
- ✓ Participatory planning—
The process was designed so that the diverse voices of the community could participate in every stage of visioning and strategic planning.
- ✓ Shared responsibility—
Community members formed a Strategic Planning Group that coordinated the planning effort, worked closely with the Truman School team, and shared responsibility for developing all products of the process.
- ✓ Action-based—
The purpose of community visioning and strategic planning was to build a shared vision of the community's desired future, set goals and objectives for the City, and design action plans that provide guidance for operations.
- ✓ On-going renewal—
To be useful as means to achieve a desired future, strategic plans must be living documents that can be

subjected to on-going analysis and revision over time. The effectiveness of any process requires that it builds capacity within the community so that on-going renewal of the vision and plan can be realized.

Thank you to all the dedicated people who made this visioning process happen. It is evident how much time and effort went into preparing the city's road map and related guidance for the future. As we celebrate St. Charles' Bicentennial, it is a perfect opportunity to plan for the next 200 years and beyond.
