The above stated fines reflect the prepay amount if paid out of court at the Violation Bureau in a timely fashion. In court, the Judge may assess a fine from \$0.00 to \$500.00 (or a maximum of \$225.00 regarding Minor Traffic Violations as defined by RSMo 479.350) and/or one (1) day to ninety (90) days in jail for a violation not defined as a Minor Traffic Violation, per charge.

PLEASE NOTE: A WARRANT WILL BE ISSUED FOR YOUR ARREST IF YOU FAIL TO APPEAR IN COURT OR YOUR PAYMENT HAS NOT BEEN RECEIVED BY YOUR SCHEDULED APPEARANCE DATE.
